When IT assets come to the end of their useful life, disposition can be a tricky, time-consuming task that presents financial and reputational risks for your organization if performed poorly or incorrectly.



## MANAGING THE PROCESS

When processing thousands of assets in different ways, across multiple locations with many stakeholders involved, there is a high risk of overrunning deadlines, going over budget, missing critical steps, and communication breakdowns. Having a capable and experienced project manager in place is paramount to mitigating this risk.

Recently, a global investment bank decided to exit multiple data centers - including four in the USA and two in Australia - and realized that project management support from Apto would be crucial.

Without external support, it can be difficult for large organizations to have all the answers. Not having that clear picture then leads to poor assumptions and a flawed project plan.



## SECURELY SANITIZING SENSITIVE DATA

Data breaches have severe repercussions for organizations. With highly sensitive data, performing data sanitization on-site may be preferable or even mandatory, as it eradicates any chance of compromise.

This was the case with Apto's global investment bank client. In total, 46% of the assets required onsite shredding, for which we provided the client with a Certificate of Destruction. The rest we securely erased onsite per guidelines set by the National Institute of Standards and Technology (NIST).

With less sensitive data, it can be more cost-effective to sanitize data offsite. However, it's essential that all necessary precautions are taken in getting assets from A to B.



## AUGMENTING YOUR TEAM

The ITAD process has many steps, each requiring personnel with different skills and experience. Rarely will a single organization possess all of these necessary resources internally.
